

SPECIFIC RULES FOR KYS BOWL

In addition to the General Rules posted on the website for Station, which is owned and operated by the Company, the following Specific Rules apply to this Promotion. Please consult those General Rules in addition to these Specific Rules. All capitalized terms not defined in these Specific Rules will have the meanings established in the General Rules. In the event there is a discrepancy or inconsistency between those General Rules and these Specific Rules, these Specific Rules shall control. The 19th caller who also correctly combines the Words into the Phrase will win.
- Entry Period: The Entry Period ends on April 11, 2025; however, Participants need to listen to the Station each weekday during the Promotion Period at the times noted above in order to win.
