

## **SPECIFIC RULES FOR WHO'S THAT ONE? COMEDY SEARCH 2026**

In addition to the General Rules posted on the Station website, following Specific Rules apply to this Promotion. Please consult those General Rules in addition to these Specific Rules. All capitalized terms not defined in these Specific Rules will have the meanings established in the General Rules. In the event there is a discrepancy or inconsistency between those General Rules and these Specific Rules, these Specific Rules shall control. The General Rules and these Specific Rules shall be collectively referred to as the "Official Rules".

### **PROMOTION DESCRIPTION:**

Station:	WKYS-FM and WMMJ-FM, which are owned and operated by Urban One d/b/a/ Radio One Washington, DC (individually and collectively, the "Station").
Promotion:	Who's That One? Comedy Search 2026
Promotion Period:	The Promotion will run from January 12, 2026, and ends on February 5, 2026.
Eligibility:	Each Participant must be eighteen (18) or older, a legal residence of the United States, and residents of the Washington, DC, metropolitan area to participate in this Promotion. Participants may not have won a prize in another promotion of any kind in the thirty (30) days before the beginning of the Promotion Period from any radio stations owned or operated by Radio One Washington, DC, to be eligible to participate in this Promotion.
Entry Period	All Entries must be received by 11:59 PM ET on January 22, 2026, to be eligible for this Promotion.
Number of Entries	Participants may only submit only one Entry for this Promotion.
Entry Method:	Participants must submit their Entry at the Station's website and follow the instructions there: <a href="http://www.kysdc.com">www.kysdc.com</a> or <a href="http://www.mymajicdc.com">www.mymajicdc.com</a> (collectively, the "Website"). The Entry must include a video of the Participant doing a stand-up comedy act (the "Recorded Performance") and a photo of the Participant ("Photo"). Both the Photo and Recorded Performance must meet the "Entry Requirements" noted below as determined by the Station in its sole discretion to be eligible for the Promotion.
Selection of the Semi-Finalists:	On January 23, 2026, the Station will review all Entries and shall pick the ten (10) best Recorded Performances based on originality, stage presence, and crowd appeal (each, a "Semi-Finalist"). Station reserves the right to increase or decrease this number of Semi-Finalists based on the number and/or the quality of Entries received.
The Finalist Prize:	The Station will post the Recorded Performances and Photo from each of the eligible Entries on the Website. From January 26, 2026, to 11:59 PM on January 30, 2026, the general public will have the opportunity to vote for their favorite Semi-Finalist. The 2 (two) Semi-Finalist with the most votes will become the "Finalists" and move onto the Open Mic Night, as described below. The approximate retail value of the Finalist Prize is Zero Dollars (\$0.00).

**Winner Selection:** The two be (2) Finalists will be given the opportunity to perform between three (3) and five (5) minutes of stand-up comedy at the 93.9 WKYS and Majic 102.3 Open Mic Night at Felt Lounge inside the MGM National Harbor, 101 MGM National Avenue, Oxon Hill, MD 20745, on Thursday, February 5, 2026, from 7:00 PM until 9:00 PM ("Open Mic Night"). The exact time of the Finalist's performance will be determined by the Station in its sole discretion. The attendees of the Open Mic Night will vote on the Winner. The Finalist with the most votes will be the Winner and awarded the Prize, as described below.

**Prize:** The Winner shall be given the opportunity to be the opening stand-up comedy act for the We Them One's Comedy Tour, Sunday, March 1, 2026, at 7:00 PM, at Eagle Bank Arena, 4500 Patriot Circle, Fairfax, VA 22030 ("Venue"). The exact time of the Winner's performance will be determined by the Station in its sole discretion. The approximate retail value of the Prize is Zero Dollars (\$0.00).

## **ENTRY REQUIREMENTS:**

### **Photo:**

- May not contain logos of any kind on any item of clothing or in the background;
- May not infringe upon any rights of any third party including without limitation, copyright, trademark, and right of publicity or privacy;
- May not contain obscene gestures;
- May not contain any nudity; and,
- Must be appropriate for all audiences and "family friendly", as determined by the Station in its sole discretion.

### **Recorded Performance:**

- Should be between two (2) and five (5) minutes in length;
- Video clips must be submitted in MP4 format;
- May not contain logos of any kind on any item of clothing or in the background;
- May not be patently offensive, illegal, pornographic or obscene, or similarly inappropriate.
- May not contain any profanity, obscene language, lewd or sexual content or references.
- May not infringe upon any rights of any third party including without limitation, copyright, trademark and right of publicity or privacy;
- May not contain derogatory characterizations of any ethnic, racial, sexual or religious groups, humiliate other people (publicly or otherwise), or otherwise assault or threaten others; and,
- Must be appropriate for all audiences and "family friendly", as determined by the Station in its sole discretion.

## **ADDITIONAL INFORMATION**

Each Participant understands and agrees that the Photo and the Recorded Performance submitting with the Entry may be posted on the Website. By submitting and Entry, each Participant grants permission to the Station to use the Photo and the Recorded Performance, including but not limited to, the Participant's name, voice, or likeness as embedded in the Photo and the Recorded

Performance in any media now known or hereafter devised related to the administration, advertising, or broadcasting of this Promotions, future promotions, or the Station.

Participants shall indemnify and hold harmless the Station, its parent company and affiliates, and each of their directors, officers, employees, and agents from any claims, damages, losses, and expenses, including but not limited to attorneys' fees and any claims alleging infringement of any third party's intellectual property or publicity rights, that may arise regarding Participant's violation of the Official Rules, including but not limited to the content of the Photo, the Recorded Performance (including but not limited to the posting of the Photo and the Recorded Performance on the Website), the material performed at the Open Mic Night, if applicable, and the material performed at the We Them Ones Comedy Tour, if applicable.

If a Finalist or a Winner is unable or unwilling to participate in the Open Mic Night or the We Them Ones Comedy Tour, no alternate prizes will be awarded. Transportation to and from the Open Mic Night and the Venue for the We Them Ones Comedy Tour, and any other incidental or other expenses related to submitting an Entry or participating in the Promotion as a Semi-Finalist, a Finalist, and/or the Winner are the sole responsibility of the Participant.

For the purposes of the Official Rules, the term "Prize" from the Official Rules shall apply to the "Finalist Prize" and "Prize".
